01 Pre-development phase

NEEDS

The needs and challenges of a nature-based project vary according to the stage of its lifecycle.

At the Pre-development phase project developers need to:

- Define project feasibility, objectives, scope, and stakeholders to enable Project Development Document (PDD) Design
- Lay the groundwork for the project's success by clearly outlining goals and expectations.
- Collect information and implement the project plan to achieve project validation.
- Allocate resources efficiently, and ensure effective communication among team members to stay on track.
